SUBJECT: Upcoming Changes to Miscellaneous Insurance Deductions

The following is a listing of approved/accepted changes to miscellaneous deductions for 2005 implementation:

1. American Public Life was approved for a new Dental (Select Dental II 2/02 LA) policy, which will be eligible for flex (pre-tax) July 2005, to be implemented January 2005. NOTE: A change will also be made in January to the Dental product for American Public. We will no longer have 2 codes, but will convert all policies to one dental code. This will be handled between eEnrollment and ISIS HR. **After this change, all one-time refunds/deductions must be processed using the Denta Care I product in eEnrollment.**
2. American Public Life was approved for a new Whole Life (WL-2 4/97) policy, which is not eligible for flex, to be implemented January 2005.
3. Colonial Life & Accident was approved for a new Accident (ACCPOL-LA) policy, which is not eligible for flex, to be implemented Jan 2005.
4. Columbian Life Ins. is a new vendor and was approved for a new Term Life (Critical Life 1F558CL/1F559CL) policy, which is not eligible for flex, to be implemented January 2005.
5. Loyal American Life was approved for a new Whole Life (L-4511) policy, which is not eligible for flex, to be implemented January 2005.
6. Protective Life was approved for a new Term Life (Protective Term Life TL-06) policy, which is not eligible for flex, to be implemented January 2005.
7. AFLAC's request for a re-rate (increase/decrease) for Cancer and Intensive Care policies was accepted to be implemented July 2005.
8. American Public's request for a rate increase for Cancer policies was accepted to be implemented July 2005.
9. Colonial Life & Accident's request for a rate increase for Cancer policies was accepted to be implemented July 2005.

10. Starmount Life's request for a rate increase for Dental policies was accepted to be implemented July 2005.
11. Consecro was approved for an enhancement to their Cancer & Cancer C/V policies (will stop soliciting the old [CH00A/PS1ST-B] for the new CHIC-6022C) to be implemented February 2005. The Cancer policy will be eligible for flex (pre-tax) in July 2005. The Cancer C/V policy is not eligible for flex.
12. MSofA Dent-All was approved for an enhancement to their Dental policies (will stop soliciting the old [The Dent-All All in One Plan] for the new DAP 2), which will be eligible for flex (pre-tax) July 2005, to be implemented February 2005.

Additional details for items 7-12 changes will be forwarded in future OSUP memoranda.
