CONSENT JUDGMENT

**WHEREAS**, the State of Louisiana, Governor's Office of Homeland Security and Emergency Preparedness (hereinafter, "GOHSEP") filed its Petition for Declaratory Judgment and for Judgment to Recover Hazard Mitigation Grant Program Funds on August 26, 2015 alleging that FEMA grant funds in the amount of \$26,388.38 were paid to Defendants, Tam Nguyen Huynh and Khoa Ngoc Huynh, by the State of Louisiana's Hazard Mitigation Grant Program (hereinafter, "HMGP") on or about July 23, 2010 for the specific purpose of mitigating their home located at 2444 Paige Janette Drive, Harvey, Louisiana 70058.

**WHEREAS**, the parties have agreed to resolve their claims without the need for litigation;

**WHEREAS**, Defendants have consented to entry of this Consent Judgment without trial or adjudication of any issue of fact or law and to waive any appeal if the Consent Judgment is entered as submitted by the parties;

**WHEREAS**, Defendants, by entering into this Consent Judgment, do admit the allegations of the Petition;

**WHEREAS**, the intention of GOHSEP in effecting this settlement is to remediate the effect of the failure of the Defendants to apply the FEMA grant funds in the amount of \$26,388.38 for the specific purpose of mitigating their home;

**WHEREAS**, Defendants have entered into a repayment agreement with the State of Louisiana, with the amount of \$2,056.12 reflecting the payments made to the State leaving a balance of 26,388.38;

**WHEREAS**, this Court retains jurisdiction for the duration of this Consent Judgment to enforce its terms;

**WHEREAS**, the effective date of this Consent Judgment shall be the date on which the Consent Judgment has been entered by the Court and has become final and non-appealable;


AND WHEREAS, each party to this litigation will bear its own costs and attorney fees, if any, associated with this litigation.

ACCORDINGLY, IT IS ORDERED, ADJUDGED AND DECREED that there be judgment herein in favor of the Plaintiff, GOHSEP, and against the Defendants, Tam Nguyen Huynh and Khoa Ngoc Huynh, in the amount of \$26,388.38, plus all costs and judicial interest from the date of demand.


