IT IS FURTHER ORDERED, ADJUDGED AND DECREED: That item #1 be and is hereby transferred to the State of Louisiana, acting through the District Attorney for the Nineteenth Judicial District free and clear of all liens and encumbrances except as specifically recognized herein above, recognizing ownership in the same as of the date of the commission of the conduct giving rise to the forfeiture, with full power of said District Attorney to dispose of said property pursuant to La. R.S. 40:2601, et seq., and in the event of a public sale, that the East Baton Rouge Parish Sheriff Office is directed to sell said property, without appraisalment, for cash to the highest bidder, subject to the lien and/or encumbrance recognized herein, with full power to execute Bills of Sale and all other necessary documents to evidence and effectuate such sales, and to disburse all proceeds of such sales pursuant to this Judgment, together with an accounting of the costs of sale attributable to each such item.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED: That all agencies having the duty to maintain record of title to items sold pursuant to this Judgment forthwith cancel title
