A. Summary of Changes

The purpose of Action Plan Amendment 21 is an existing program name change for Rural Bond Bundle Program, along with changes to the program structure removing financing requirements using bonds and Low Income Housing Tax Credits (LIHTCs), modify the design and budget of the OCD CDBG Homeownership (OCHO) Pilot Program, and reduce funds allocated to the Multifamily Rental GAP Program as it was undersubscribed.

This APA is considered substantial, as it changes the original scope and name of the Rural Bond Bundle Program to the Rural Repair and Rehabilitation Program. It also changes the scope of the OCHO Pilot program along with the re-allocation of funds which constitutes a change of 15 percent or great of a program budget.

C. Existing Program Description Modifications

1. Rural Repair and Rehabilitation Program

Summary of change: Through Action Plan Amendment 16, the state introduced the Rural Bond Bundle Program (RBBP), which leveraged CDBG-DR fund with bond financing and Low Income Housing Tax Credits to rehabilitate multi-family affordable housing properties in impacted areas previously financed through the U.S. Department of Agriculture (USDA) Rural Development (RD) in need of repair or rehabilitation. As the initial response to the RBBP fund availability offering was limited, and the time constraints associated with the RBBP funding were inconsistent with the needs of other funding sources, through this amendment the state is modifying the means of distribution of funding for repair and rehabilitation of rural multifamily properties by removing the specification that bond funding and LIHTCs are a necessary source of project financing, or that properties are grouped (i.e. bundled) for award purposes, and renaming the program "Rural Repair and Rehabilitation."

The state, in the program policies, may prioritize properties in need of repair or rehabilitation that have pre-existing USDA RD financing, The state may extend the program to other rural multifamily housing properties if the state determines that sufficient funds exist in the program or that project completion of a prioritized project cannot reasonably be anticipated, in the state's estimation, within the time constraints needed for the CDBG-DR funding under this program.

2. OCD CDBG Homeownership (OCHO) Pilot Program

Summary of change: Action Plan Amendment (APA) No. 16 created and allocated funds to the OCD CDBG Homeownership (OCHO) Pilot Program. Under OCHO, LLT would transfer approximately 20 pad-ready lots in Audubon Estates to an eligible non-profit. The non-profit would receive CDBG-DR funding from OCD to cover 100% of home construction. The Grantee would then sell those homes to qualified Low to Moderate Income (LMI) home buyers.

The new approach will improve implementation efficiencies by separating the construction phase from the disposition of home. Utilizing resources already in place, OCD and LLT will manage construction of the affordable housing units using CDBG-DR funds. During the construction phase, OCD will select an eligible applicant to market and sell the homes to Low to Moderate Income (LMI) households. Through issuance of a Notice of Funding Availability (NOFA), the awarded applicant will be responsible for marketing and selling these newly constructed homes to qualified home buyers under the terms as allowed by the Program.
