**SUBJECT: THIRD PARTY ADMINISTRATOR CHANGE – Reporting Procedures**

Claims management and Loss Prevention services for the Office of Risk Management will transfer to Sedgwick CMS on August 1, 2015. This notice contains revised reporting procedures and contact information for Sedgwick CMS.

**Reporting Claims**

1. Agencies will report Worker's Compensation and General Liability claims online utilizing Sedgwick's online claim entry system, Claims Capture. User IDs and login credentials are currently being emailed. In the event there is an issue with logging into the system, claims can be reported using the following:
