RE: State Funds Utilized to match FEMA Federal Funds

The – U.S. Troop Readiness, Veterans’ Care, Katrina Recovery, and Iraq Accountability Appropriations ACT of 2007 (“War Funding ACT”), passed by Congress, and signed by the President, requires among other things, the federal government to carry out certain project expenditures under the Federal Emergency Management Act (FEMA) at full Federal expense. As a result of this act, State funds expended on FEMA related projects to match federal funds will be reimbursed.

This memorandum therefore is to request information on state funds spent as matching funds for disaster related expenditures to ensure the State gets reimbursed for all funds utilized as match for disaster related expenditures.

Please indicate in your response if you provided match for FEMA funds for any expenditures in State Fiscal Years 2006 and 2007. If you expended state funds for FEMA match in either of these years, provide the amount of the match, the amount of the FEMA funds, the Project Worksheet Number and a brief description of the expenditure or project. Also indicate in your response if the state subsequently reimbursed you for these expenditures.

For State Fiscal Years 2006 and 2007, please respond to the Office of Planning and Budget, through your Budget Analyst, no later than Monday, June 18, 2007.

If you are providing any match for FEMA funds for any expenditures in ensuing State Fiscal Year 2008, please respond by contacting your Budget Analyst via e-mail or telephone, no later than before close of business Tuesday, June 12, 2007.
