SUBJECT: Upcoming Changes to Statewide Vendor Deductions

The following is a listing of approved/accepted changes to statewide vendor deductions for 2009 implementation:

1. Colonial Life & Accident's request for a rate increase for Cancer policy riders was accepted to be implemented July 1, 2009.
2. Transamerica Life's (formerly Life Investors) requests for rate increases for Cancer and Cancer C/V policies were accepted to be implemented July 1, 2009.
3. Kanawha Insurance (formerly Columbian Life) was approved for an enhancement to their Term Life policies (will stop soliciting the old 20235 6/02 for the new 8013-LA) to be implemented February 2009. The enhanced Term Life policy is not eligible for flex.
4. Protective Life was approved for an enhancement to their Term Life policies (will stop soliciting the old TL 12 for the new Enhanced TL 12) to be implemented February 2009. The enhanced Term Life policy is not eligible for flex.
5. Protective Life was approved for an enhancement to their Universal Life policies (will stop soliciting the old UL 09 for the new UL 15) to be implemented February 2009. The enhanced Universal Life policy is not eligible for flex.

Additional details regarding the changes noted in items 1-2 will be forwarded in future OSUP memoranda.
