To assist the State of Louisiana recovery from the devastation caused by Hurricane's Katrina and Rita, Congress approved two appropriations of funding of \$6,210,000,000 in P.L. 109-148 and \$4,200,000,000 in P.L. 109-234.

This funding will be used for a comprehensive array of programs designed to aid of the recovery of coastal Louisiana. In the First Action Plan for disaster recovery funds, the state allocated funds into three categories. The Second Action Plan for disaster recovery funds is an extension of the first Action Plan's targeted goals. The disaster recovery CDBG funds are directed to be used for Housing, Infrastructure, and Economic Development. This Action Plan allocates the \$4.2 billion in supplemental funding granted to Louisiana. These dollars will fully fund Louisiana's recovery housing programs, collectively titled the Road Home Housing Programs, which are designed to allow displaced Louisiana citizens to return to there homes. \$3,608,800,000 of this funding is for the Road Home Housing Programs. Additionally, \$41,200,000 that has been previously approved for administration within the first Action Plan will be funded from the second allocation. The Second Action Plan includes currently unallocated funds of \$550,000,000. The unallocated funds will be used within the Infrastructure category of needs, as well as additional funding for costs related this additional allocation. The purpose of the Road Home program is to meet urgent community recovery needs including redevelopment and to revitalize the housing of hurricane affected areas.

Proposed of Second Action Plan Funds

Louisiana plans on using the \$4.2 billion appropriated by Congress under PL 109-234 for housing programs, for both owner-occupants and rental units. A considerable amount of funds remains officially unallocated, but it is anticipated that most of this balance will be used for infrastructure needs as well as monies for rebuilding health care facilities in New Orleans. This includes: assistance to owner occupants to compensate them for their hurricane loss; a small rental property repair program designed to serve small properties and target assistance to small owners; for supportive housing for special needs population; and for another rental program involving the low income housing tax credits. Funds are allocated in the following manner:

In keeping with the Statute and language in HUD's notice FR-5089-N-01 from October 30, 2006, the Second Action Plan clearly demonstrates that the State of Louisiana "has identified dedicated resources sufficient to meet the key disaster recovery needs for repair, rehabilitation, and reconstruction of affordable rental housing stock, including public housing, in the most impacted areas of the State." The State is keenly aware of

the need to support affordable rental housing in the wake of the damage caused by Katrina and Rita. In fact, the State’s response far exceeds the requirements of PL 109-234. Not only does this plan devote approximately \$1.113B of its \$4.2B second allocation to rental housing needs, the State’s overall plan, including both the first allocation and the second allocation, commits over \$1.5B of assistance for rental housing programs.

The State of Louisiana will target 70 percent of its disaster recovery funds under Public Law 109–234 towards the disaster recovery needs in the New Orleans-Metairie-Bogalusa Metropolitan Area.
