

**MINUTES OF THE  
LOUISIANA LANDSCAPE ARCHITECTS SELECTION BOARD  
April 24, 2024**

A meeting of the Louisiana Landscape Architects Selection Board (LLASB) was held in the Claiborne Building, 1201 N. Third Street, Room 1-145 James Monroe Room, Baton Rouge, Louisiana 70802 on April 24, 2024.

The meeting was called to order at 10:02 a.m. by Mr. Justin K. Lemoine, Chairman. Those members present were: Mr. Justin K. Lemoine, Mr. Daniel W. McElmurray, Mr. Christopher M. Pulaski, Mr. Stephen A. Shurtz and Mr. Roger Husser, Jr. Those members absent were: none. Also present as Legal Counsel was Mr. Ryan Seidemann, Attorney General's Office.
