I. Overview:

This Action Plan Amendment No. 71 amends allocations to the Primary and Secondary Education, Local Government, and Fisheries Assistance Programs; and the Planning and State Administration budgets. This amendment is considered non-substantial because it does not create a new program, does not change any eligible beneficiaries and does not re-allocate more than 15% of funds in any program.

II. Reallocation of Funds for Existing Programs:

A. Primary and Secondary Education

The Primary and Secondary Education budget is reduced to \$243,694,307.58 because funds have been de-obligated from activities that are completed and closed out. This program was created in Action Plan Amendment 2 and amended in Amendments 19, 53, 61, and 67.

B. Fisheries Assistance

The Fisheries Assistance budget is reduced to \$25,378,614.71 because funds have been de-obligated from activities that are complete and in the closeout process. This program was created in Action Plan Amendment 17 and amended in Amendments 26, 54, 62, and 67.

C. Planning

The Planning budget is reduced to \$15,297,329.50 because funds have been de-obligated from activities that are completed and closed out. This program was created in the Initial Action Plan and amended in Amendments 16, 22 and 64.

D. State Administration

The State Administration budget is reduced to \$131,649,465.32 because funds have been de-obligated from activities that are completed and closed out. This program was created in the Initial Action Plan and amended in Amendments 1, 49, 63, and 64.

E. Local Government Infrastructure Program

The Local Government Infrastructure budget is increased to \$142,992,020.61 in order to fund an eligible activity to continue to meet the ongoing critical recovery needs of public entities. This program was created in the Initial Action Plan and amended in Amendments 2, 15, 19, 25, 41, 48, 49, 53, 54, 67 and 70.
