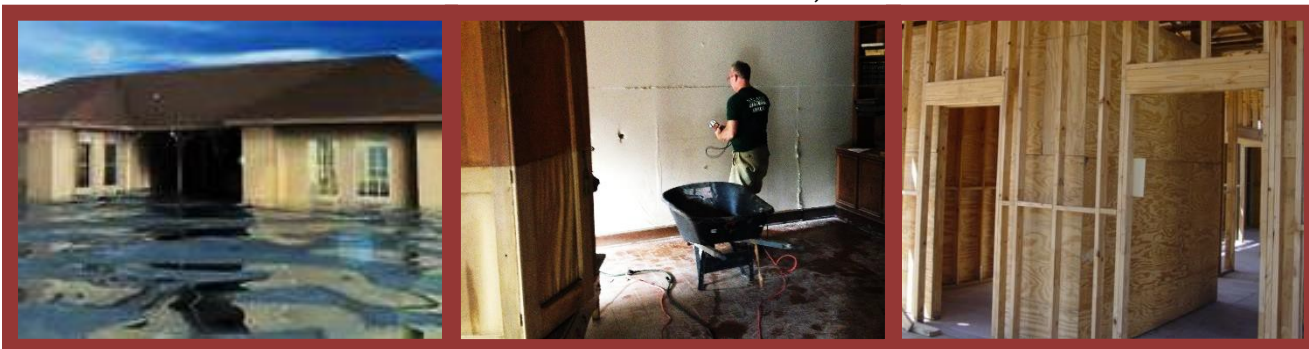

A. Summary of Changes

The purpose of Action Plan Amendment 24 is to decrease the *Homeowner Assistance Program* and increase the *Piggyback Program*, and *Administration and Planning* budgets.

Per the state's Master Action Plan, this amendment is considered non-substantial as it does not change the benefit or eligibility criteria, add or delete an activity, or re-allocate more than \$5 million dollars or 15 percent or greater of a program budget.
