SUBJECT: GASB 75 Other Postemployment Benefits (OPEB) Liability

Attached is the Schedule of Employer OPEB Amounts for FY 2020 (the OPEB Schedule, Exhibit A) and the Schedule of Future Amortization (Exhibit B) for entities that participate in the health and life insurance plans administered by the Office of Group Benefits (OGB). The schedules are located on OSRAP's website at (http://www.doa.la.gov/Pages/OSRAP/afrpackets.aspx). Click on the tab "GASB 75 - 2020 OGB OPEB Liability and Related Amounts." The OGB OPEB schedule includes the OPEB expense, deferred inflows and outflows related to OPEB, and the OPEB liability for proprietary entities and discrete component units reported in the State's Comprehensive Annual Financial Report (CAFR). If your entity has an OGB OPEB liability and is reported as an internal service fund, business-type activity (BTA), or discrete component unit in the State's CAFR, please use the OPEB amounts on the attached schedule (Exhibit A) when preparing your entity's Annual Fiscal Report (AFR). The Schedule of Future Amortization (Exhibit B) may be used for your entities separately issued financial statements, but they are not needed for the AFR, since the actuary has provided OSRAP with this information.

The amounts reflected on the Schedule of Employer OPEB Amounts for the deferred inflows and deferred outflows are FY 2020 ending balances. We have attached the OPEB journal entries for the Division of Administrative Law (ISIS agency #816) to be used as a guide in preparing your entity's journal entries (Exhibit D). The journal entries credit or debit various deferred inflows and deferred outflows accounts related to OPEB by the amount of the difference between expected and actual experience, changes in assumptions, etc. (see Exhibit C). The various deferred inflows related to OPEB should be combined and entered on one account line on the Statement of Net Position (SNP) and the various deferred outflows related to OPEB should be combined and reported on one account line on the SNP.

Last year, a new account line was added to record the current portion of the OPEB liability. The GASB allows the benefit payments made subsequent to the measurement date to be used as the current portion of OPEB liability for those entities with a 6/30 year-end. The OPEB liability, as of the measurement date 6/30/19, is reflected in the financial statements for the year-ended 6/30/20. A journal entry has been added to Exhibit D to display that the current OPEB liability is equivalent to the amount of "Deferred Outflows Related to OPEB - CY Benefit Payments Made Subsequent to Measurement Date."

The attached OPEB schedule does not include the amount for the last journal entry in the example; i.e., CY contributions made subsequent to the measurement date. As a reminder, deferred outflows related to OPEB on your entity's FY 2020 financial statements should equal the total of your agency's deferred outflows shown on the OPEB schedule, plus the amount of the current year (FY 2020) OPEB benefit payments made subsequent to the measurement date. All of your agency's deferred inflows related to the OGB OPEB is reflected in Exhibit A.
