RE: ProAct Enhancements

In order to increase efficiency within the Office of State Procurement Professional Contracts, some enhancements have been made to ProAct.

The enhancements are:

### **RFP Process**

- Creation of a new RFP approval certificate. When an RFP is approved, an RFP approval certificate will be emailed as an attachment to the end user. This approval certificate will also be accessible in PROACT for the approved RFP.
- RFP Template a link to the template is provided under the attachments tab.
- PST Budget Form this new form can be accessed via the RFP attachments tab (to be used if applicable).

### **Contract Process**

- Creation of a new "RFP Info" tab for Contracts. This tab will allow agencies to attach all supporting RFP documentation to the contract transmittal. Note: These steps have been removed from the RFP transmittal processes.
- If Attorney General review is selected, Office of General Counsel review must also be selected (and vice versa). If contract goes to one of these entities for review, it must also go to the other.

- Performance Evaluation Agencies will now have the ability to attach a Performance Evaluation for approved contracts and Submit for Review. Instructions for this process can be found in the User Guide (HELP link in the system).
- Contracts approved under an Agency's delegation can now be submitted to the Office of State Procurement for reporting purposes only. A new "Approved Under Delegation" checkbox has been added to the Information tab.

## **Amendment Process**

• Discretionary/Non-Discretionary (Act 87) indicator added to the information tab.
