

## MICROSOFT ENTERPRISE AGREEMENT

### Microsoft EA #01E73758

**TYPE OF CONTRACT:** Master Software License and Pricing Agreement

**CUSTOMER:** State of Louisiana agencies, departments and political subdivisions

**CONTRACT TERM:** September 1, 2014 through August 31, 2017

**PRICING:** Level D. Agencies who currently have an EA will be able to purchase “renewal” pricing at a reduced cost per desktop.

**SCOPE:** This Microsoft Enterprise Agreement is separate and apart from the current Microsoft Select Agreement in that it will make it easier for agencies interested in standardizing on the Microsoft Enterprise platform of products to acquire their Microsoft software.

**ORDER PLACEMENT:** To obtain contract pricing, orders must be placed through a Microsoft authorized Large Account Reseller (LAR). The following LARS have enrolled with the Office of State Purchasing:
